Appointment of new CEO and Global CFO of Roust Corporation

Roust Corporation announces that effective December 13, 2017, Monzer Elabrashy, who had been serving as Global Chief Executive Officer (CEO) of Roust Corporation, has been replaced by Pavel Merkul, who was appointed as new Global CEO. Roust Corporation also announces the appointment of Yaroslav Zakharov as the Global Chief Financial Officer (CFO) of Roust Corporation, effective December 13, 2017.

Mr. Merkul (37) has been a Director of the Company since June 5, 2013. Mr. Merkul has joined Russian Standard in 2009 and was appointed to the position of Managing Director of Russian Standard Corporation in 2013. In this position he was responsible for the key strategic projects of Russian Standard Group, including mergers and acquisitions, post-merger integration and business development, as well as Russian Standard Group's finances. He began his career in 2001 working on various financial and business turnaround projects in Russia. Mr. Merkul then worked with a leading global management consulting firm the Boston Consulting Group from 2004 through 2009, focusing on strategy development and execution, operational efficiency and business portfolio management projects for both multinational and local companies. He received his BA in economics from Moscow State University and his MBA from INSEAD in France and Singapore. Mr. Merkul's unique skills and extensive successful experience will reinforce the company's position as the world's second largest vodka producer and the largest alcohol producer in Central and Eastern Europe and Russia.

Mr. Zakharov (42) has been Roust Russia CFO since October 18, 2017. In the position of Roust Global CFO, Mr. Zakharov will be responsible for the financial management of all our companies and production sites. Mr. Zakharov began his career in 1995 joining the multinational FMCG giant PepsiCo. In 2001, he moved to AB InBev, a world leading brewer, where he worked his way up from a finance controller to the Finance Director responsible for Strategic Planning & Business Performance Management in Central & Eastern Europe. During his tenure at AB InBev, Mr. Zakharov also had direct commercial experience, successfully running Sales in the capacity of Regional Sales Director and National On-Trade channel Director. In 2014, Mr. Zakharov continued his career as CFO for Russia, India, the Middle East, Turkey and Africa at Kraft Heinz. He received his MSc in Economics and Business Management from Sochi State University for Tourism and Recreation, and his MBA from INSEAD. Mr. Zakharov's extensive successful experience in finance was a key factor in his appointment as Roust Global CFO.

Resignation of Directors

Roust Corporation also announces the resignations of Neal Goldman and Spencer Wells from its Board of Directors, effective December 14, 2017. Prior to his resignation, Mr. Wells served as the Chairman of the Audit Committee of the Board of Directors.

Roust is one of the world's largest vodka producers, maintaining leading positions in all its key markets, including Poland, Russia and Hungary.
