Roust Corporation (the "**Company**") announces that it expects to file its annual report on Form 10-K for the year ended December 31, 2017 (the "**2017 10-K**") on or about April 6, 2018.

The publication of the 2017 10-K will be later than April 2, 2018 (the scheduled publication date for this report) because of the time required to prepare the 2017 financial statements in light of the Company's restructuring process completed in 2017, as a result of which the Company was not able to complete and publish the 2017 10-K by April 2, 2018 without unreasonable effort or expense.

This report shall be considered a Form 12b-25, and accordingly, the deadline for filing the report shall be extended for 15 days in accordance with SEC rules (Rule 12b-12(b)), and the Company will file the report no later than 15 days after the originally required filing date. The Company has published all reports required to be published during the preceding 12 months. With respect to anticipated 2017 results, the Company notes the disclosure to investors in the Form 8-K published on January 30, 2018 which included a discussion of preliminary results for 2017.
